WELCOME / INTRODUCTIONS

APPROVAL OF MEETING MINUTES

MOTION: A motion was made to approve the August 3, 2007, meeting minutes.

The motion was seconded and carried unanimously.

DRAFT PROPOSED SCOPE AND OBJECTIVES FOR 2008 TAX PREFERENCE REVIEWS

Gary Benson presented draft Proposed Scope and Objectives for the 2008 Full and Expedited Tax Preference Reviews. Objectives for Full reviews remain much the same as for the 2007 reviews with the exception that if, after preliminary review, the Commission determines a tax preference does not require a full review, the preference can be moved to the Expedited review list. Objectives for Expedited reviews are significantly less arduous than for the 2007 reviews. Mr. Benson also proposed a standard for determining a tax preference to be "de minimus," in which case it would not be reviewed.

Commission Discussion

The Commission discussed changes from the 2007 reviews and appropriate standards for Expedited reviews. The Commission also discussed, and agreed not to include, a standard for

determining a tax preference de minimus in the Proposed Scope and Objectives for Expedited reviews.

2008 TAX PREFERENCE REVIEW SCHEDULE

Gary Benson presented a Draft 2008 10-Year Tax Preference Review Schedule. Mr. Benson also presented staff-recommended changes to the Draft Review Schedule.

Commission Discussion

The Commission discussed changes to the Draft Review Schedule, specifically the recommendation to move Household Goods to the list of preferences not subject to review. The Commission also discussed defining a "critical part of the tax structure." Ruta Fanning explained that in EHB 1069, the Legislature did not define what is critical to the tax structure, but instead allows the Commission to make that definition.

MOTION: A motion was made to approve the Draft 2008 10-Year Tax Preference Review

Schedule as proposed, including staff-recommended changes.

The motion was seconded and carried unanimously.
